Summary in English

Surrealism emerged as the French poet and critic André Breton who announced the first statement rejecting the laws and cultures that crippled human thought. Rather, it exaggerated his filming, and was beyond reality in its terms. Hence the word "sur realism" which means "super realism".

Psychological research was not only the only driver of the rise of surrealism but also the political environment: in 1924 World War had a direct and major influence on the emergence of movements, of which surrealism is an important model.

The Surrealist emerged as a literary revolution, but it was more pronounced in plastic art. Artists had a strong sense of revolution and daring to express it in a variety of ways.

Since the birth of Surrealism has taken the form of a global phenomenon and found a response from young artists and writers, especially in Europe. On the other hand, the Surrealist appeared in Egypt, where it was adopted by the Art and Freedom Group.

Some of the features of the Surrealist thought have been transferred to the contemporary art group and its pioneers are: Abdul Hadi Al-Jazzar , Hamed Nada , Maher Raef and Samir Rafea . The members of this new group were influenced by the artistic concepts of art and freedom .

The problem of research on the group of art and freedom crystallized the problem of women literally and formally. The research also deals with the impact of the Surrealist literature and poetry on the art of Surrealism, which appeared frequently in magazines issued by the Art and Freedom Group. Poverty, which has led to a segment of poor women prostitutes. Where he was officially in Egypt and the issue of its abolition was aroused and expressed this position literally and formally by addressing the body of women in various ways.
